Situated in the heart of Covent Garden, Harry's will complement the surrounding array of acclaimed restaurants, including **Ave Mario**, **Balthazar**, **The Barbary**, **Delamina Townhouse**, **Flat Iron**, **Story Cellar**, **The Oystermen** and **SUSHISAMBA**.
